

GERMANY WANTS TO BE GIVEN FREE HAND

Sends Note to League of Nations Regarding Part She Will Play in International Conflicts.

GENEVA, Dec. 21.—(By Associated Press.)—Opening up the whole problem of German armaments, Germany has sent a note to the league of nations, touching the question of Germany's joining the league.

The text of the note, which is published in the league gazette, shows that Germany desires an exceptional position as a member of the league because of her lack of armed strength, though she desires to have the same rights and privileges as other members.

The reaction in league circles to the German note, which the Berlin government also transmitted to all other members of the league, is that it will be certain to necessitate lengthy negotiations with the powers and presumably delay the date when Germany will formally apply for admission to the league.

Dr. Gustav Stresemann, the foreign minister, himself formed the second chapter of the negotiations begun when Germany dispatched her first communications on the same subject to all the powers having seats in the council.

Conclusion Justified. Dr. Stresemann began by saying that the German government is of the opinion that political development during the last year has rendered it possible for Germany to join the league.

The foreign minister remarked that the replies received justified the wish to have a seat in the league. He explained that his object was to ascertain the attitude of the powers with regard to Germany's becoming a member of the league council and also with reference to Germany's non-participation in the league's military provisions.
